1. Introduction

Powerscreen of California, Nevada, & Hawaii (“the Company”) is committed to conducting business ethically and with integrity. We have a zero-tolerance approach to **modern slavery, human trafficking, forced labor, and child labor** in any form. This policy outlines our commitment to preventing modern slavery within our operations and supply chain and ensures compliance with all applicable laws and regulations.

2. Scope

This policy applies to:

- All employees, contractors, and consultants working for or on behalf of the Company
- All suppliers, vendors, and business partners
- All subsidiaries and affiliated entities

3. Legal Compliance

The Company adheres to the following anti-slavery laws and regulations:

United States

- **U.S. Trafficking Victims Protection Act (TVPA)** – Prohibits all forms of human trafficking and forced labor.
- **California Transparency in Supply Chains Act (SB 657)** – Requires businesses to disclose efforts to combat human trafficking in their supply chains.
- **Fair Labor Standards Act (FLSA)** – Prohibits oppressive child labor and establishes fair labor practices.
